**SECTION 12 - PUBLIC ANNOUNCEMENT SERVICE<sup>1</sup>**

12.1 General

Sponsored Public Announcement Service consists of service and facilities for use by a customer in giving to the telephone users, by means of a recording, information of public interest together with an announcement that may include advertising material.

12.2 Regulations

12.2.1 Sponsored Public Announcement Service is furnished subject to the availability of facilities and the requirements of local exchange and toll service.

12.2.2 The service will not be furnished where the circumstances are such that the proposed use of the service or facilities would tend to injuriously affect the efficiency of the Company's plant or property or service.

12.2.3 Equipment for the service could be single channel with one out-put channel or multi-channel with three out-put channels. The multi-channel equipment provides at 20-seconds intervals, three different announcement messages of 60 seconds each, two different announcements of 120 seconds and 60 seconds respectively, or one announcement message of 180 seconds. The single channel equipment provides at 14-second intervals one announcement message of 54 seconds maximum.

12.2.4 The Company shall not be liable, directly or indirectly, to the customer or any other person for any inaccurate time-of-day announcement since the accuracy of the announcement facilities may be affected by variations in the power or in the mechanical equipment used in their operation.

12.2.5 Parties calling the announcement number will be automatically disconnected after one complete announcement.

12.2.6 One alphabetical directory listing number will be furnished without charge for each service.

12.3 Obligation of the Customer

12.3.1 The customer will contract for as many announcement lines and terminal equipment as may be required in the judgement of the Company.

12.3.2 In the event that the use of an automatic-announcement service causes impairment, disruption, or deterioration of the Company's general telephone service or telephone plant, the Company shall have the right to discontinue forthwith such service without prior notification to the customer.

12.3 Obligation of the Customer (Cont.)

12.3.3 The customer indemnifies and saves the Company harmless against claims for libel, slander, or infringement of copyright arising from material furnished hereunder; and against all other claims arising out of any act or omission of the customer in connection with facilities provided by the Company.

12.3.4 The customer may not transmit over facilities furnished hereunder any material, the transmission of which is prohibited by law, or which is deemed objectionable by the Company.

12.3.5 Contracts for the announcement lines and line-terminal equipment are taken for an initial period of one month.

12.3.6 Contracts for the announcement equipment are taken for an initial period of three years. In case of termination of the service before the expiration of the initial contract period, full monthly charges for the remainder of the initial contract period apply.

12.4 Rates

Public announcement equipment, including common equipment and emergency power supply, will be installed in the Central Office.
