1.3 Rates

1.3.1 The charge for Basic Rent does not include any customer premise equipment.

1.3.2 Calls within an exchange will be metered as one message unit. Inter exchange calls within the calling zone will be metered as two message units. Message units in excess of the allowance will be charged at \$0.13.

The period of this promotional offer is from March 3, 2008 to May 31,2008. Effective June 1, 2008 this promotional offer is not available for new subscriptions.
